Membership Terms and Conditions

You sign the Membership form; you are deemed to agree with and accept these Terms and Conditions.

1. In these terms and conditions:
 - 1.1 "the Club" means ABC Club;
 - 1.2 "Membership" means each member of the Club and
 - 1.3 "Photos" refers to all the photos uploaded by the member on the website.
 - 1.4 A Member may only upload the Photo during the period as designated or accepted by the Club, but for unlimited occasions. Upon receipt of the uploaded Photo, the Club may verify or procure the verification of the uploaded Photo to be photos of the Member. Where a Member has uploaded more than one Photos during the said period, and uses the same for the all-other purposes in connection with membership with the Club.
 - 1.5 As Photos are sensitive materials, each of the Members are advised to upload his/her Photo with his/her own personal device and through a secure network. Upload of the Photos shall be at the Member's own risk and in no event shall the Club be liable for any risk arising in connection with uploading of the Photo.
 - 1.6 For upload of Photo on a Member's mobile device, the relevant mobile service provider may charge certain fees based on the volume of data transmitted and/or any other fee as may be agreed between the Member and the relevant mobile service provider.
 - 1.7 On uploading any Photo, a Member represents and warrants that Photo file shall not contain any malware.
 - 1.8 Each Member undertakes to read and understand the Club's data [privacy policy](#) before uploading any Photo and consents to the Club using any the Photo and any other personal data gathered from his/her usage of this website in accordance with the Club's data privacy policy.
 - 1.9 Without prejudice to the generality of Clauses 3 above, this webpage is not for any other purposes. For reservation for any facilities of the Club and/or handling any other matter in connection with the Club, Members shall contact the Club via the designated channels.
 - 1.10 Proof of dispatch will not be accepted as proof of successful upload of any Photo. ABC Club does not accept responsibility for any loss, damage, error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft, destruction, alteration of, or unauthorized access to entries, or entries lost or delayed whether or not arising during operation or transmission as a result of server functions, virus, bugs or other causes outside of its control, or any other loss howsoever caused.
 - 1.11 The Club shall have the right to add to, delete, amend or vary any of these Terms and Conditions in its absolute discretion. In the event of dispute, the Club's decision shall be final and binding.
 - 1.12 Commitment Period: The minimum term you are committing to remain a member of the Club from the Start Date of the commitment period end date of the last day of the membership year (subject to extension if your membership is suspended).
2. Membership:
 - 2.1 Applicant needs to be a dance institution.
 - 2.2 The contact person should be the owner or assigned representative.
 - 2.3 By signing this Membership Application Form the member agrees to comply with these terms and Conditions of Membership and the Club Rules.
 - 2.4 As part of the registration process, the Club will validate information provided by the applicant. By providing this information to the Club, the applicant certifies that such information is true and correct.
 - 2.5 You will only be permitted to enjoy the Club Special Offers provided if your membership is current and fully paid up or you have made payment arrangements acceptable to the Club.
 - 2.6 You are responsible for any use of the ABC CLUB sites that occur in conjunction with your username and password so keep your password secure and don't let any other person use your username or password.
 - 2.7 If you realize there's any unauthorized use of your password or any breach of security you need to let us know.
3. Membership Categories:
 - 3.1 The Club offers different categories of membership which are set out in the Club's information sheet. Your choice of category on joining will determine the fees you pay and any restrictions that may apply to enjoy Club offers.
 - 3.2 You may change to any other available membership category by giving one month's notice to the Club.
 - 3.3 The Club Membership cannot be transferred to another institution. In the case of improper use, membership may be terminated, and the member shall be held liable for damages incurred to the issuer as a result of such use.
4. Membership period:

5. Membership Fees:

The Club will set the level of fees and will review such fees periodically. The Club reserves the right to change the level of fees from time to time but guarantees that your fees will not change during your Commitment Period.
